1. Executive Summary

Master Plumbers Association - Canberra ACT (MPA), as the leading membership association for the plumbing sector, is once again honoured to contribute to the ACT Government's budgetary process. Our submission for the 2024-25 fiscal year is aligned with the ACT Government's strategic priorities, particularly in promoting sustainable economic growth, enhancing community wellbeing, and supporting environmental initiatives.

Our proposals are tailored to address key areas of the ACT Wellbeing Framework, emphasizing health and community wellbeing, environmental sustainability, and the pivotal role of the plumbing industry in the daily lives of ACT residents.

MPA's Key Contributions and Achievements:

- 1. **Environmental Impact and Public Health:** MPA continues to play a vital role in promoting environmental sustainability and ensuring public health and safety. Our engagement extends to over 480,000 ACT residents, reflecting our growing influence and responsibility in the region.
- Plumbing Industry Leadership Alliance (PILA) Success: Building on the success of PILA, MPA has led initiatives in community education about crucial plumbing issues, supported continuous training for professionals, and actively combated unethical practices in the industry. These efforts underscore our commitment to maintaining high standards in the plumbing sector.
- 3. **Economic Contribution:** The plumbing industry remains a critical component of the ACT economy, contributing significantly to the regional GDP and employing a large workforce of licensed professionals and support staff.

MPA's Recommendations for 2024-25:

- 1. **Expert Reports for Consumer Protection:** Support MPA in providing expert reports to address significant consumer concerns, in collaboration with Care Consumer Law and other partners. Proposed funding: \$200,000 per annum for 3 years (Total \$600,000).
- 2. **Promotion of MPA Membership and Consumer Guarantee:** Actively promote MPA Membership and our Consumer Guarantee to ensure the best outcomes for the community, government, and environment. Proposed funding: \$60,000 per annum for 3 years (Total \$180,000).
- 3. **Renewed Partnership for Zero Emissions Research:** Partner with MPA to extend our research on sustainable energy options, supporting the transition to zero emissions. Proposed funding: \$60,000 per annum for 3 years (Total \$180,000).
- 4. **Enhanced Training and Professional Excellence:** Support initiatives to expand training capacity and promote excellence within the plumbing profession. Proposed funding: \$220,000 per annum for 3 years (Total \$660,000).

The MPA remains committed to working alongside the ACT Government to ensure the prosperity and wellbeing of all Canberrans. Our proposed initiatives and funding requests are strategically designed to align with the government's priorities and to make a significant, positive impact on the ACT community.

Our key objectives are:

To continue making a substantial impact, we seek the ACT Government's support for our extensive range of programs, as detailed in Appendix 1 of our submission.

Through these efforts, MPA remains dedicated to ensuring the plumbing industry's growth and excellence, ultimately contributing to the betterment of the Canberra community and beyond.



3. Our proposals

Our proposals are framed around the central tenets for the ACT Government's budget preparations, building our economic, social, and community recovery and to support the wellbeing of Canberrans now and into the future.

In alignment with the ACT Government's objectives for economic, social, and community recovery, and to enhance the wellbeing of Canberrans, the Master Plumbers Association – Canberra ACT (MPA) presents its budget proposals for 2024-25. These proposals are designed to support the critical role of the plumbing sector in the ACT community, focusing on sustainability, professional development, and consumer protection.

1. Support for Providing Expert Reports in Consumer Disputes:

- **Objective:** Facilitate the provision of expert reports by MPA in cases of significant consumer concerns, in partnership with organizations like Care Consumer Law.
- Proposal: \$200,000 per annum for 3 years (Total \$600,000).
- **Expected Benefits:** Efficient resolution of consumer disputes, maintenance of industry credibility and professionalism, and cost savings for the government, legal system, and community.

2. Active Promotion of MPA Membership and Consumer Guarantee:

- **Objective:** Enhance public awareness and confidence in employing ethical and proficient plumbing professionals by promoting MPA Membership and the pioneering MPA Consumer Guarantee program.
- **Proposal:** \$60,000 per annum for 3 years (Total \$180,000).
- **Expected Benefits:** Improved professional standards, consumer protection, and trust in the plumbing industry, leading to cost savings for the government and community.

3. Renewed Partnership for Zero Emissions Research:

- **Objective:** Strengthen collaboration with the ACT Government in advancing evidence-based research on all energy options available for transitioning to Zero Emissions, ensuring the dissemination of accurate information.
- Proposal: \$60,000 per annum for 3 years (Total \$180,000).
- **Expected Benefits:** Accurate, evidence-based information on energy options to guide public and government decisions, supporting environmental goals and community education.

4. Support for Plumbing Skills & Workforce Needs:

- **Objective:** Address the growing demand for professional training in the plumbing sector, emphasizing the transition to zero emissions, environmental protection, and public health and safety.
- **Proposal:** \$220,000 per annum for 3 years (Total \$660,000).
- **Expected Benefits:** Easing of workforce shortage, enhancement of professional standards, and reduction in costs for the government, community, and ratepayers.



These proposals are strategically crafted to support the ACT Government's vision for a thriving, sustainable community, underpinned by a skilled and ethical plumbing sector. MPA is committed to fostering excellence in our industry for the benefit of all Canberrans and looks forward to the continued partnership with the ACT Government in achieving these objectives.



4. Conclusion and Recommendations

The plumbing industry continues to play a vital role in the ACT's evolving economic landscape, especially in the context of the region's ambitious goal to achieve Zero Emissions by 2045. Strong support from the ACT Government is essential for the industry to meet these challenges and contribute effectively to the community, environment, and government objectives. Such support will not only foster a more sustainable environment but will also enhance consumer confidence, elevate professional standards, prepare the industry for future advancements, and help eradicate unethical practices that detrimentally impact vulnerable community members.

- 4. Support for Plumbing Skills & Workforce Needs

Appendix 1 – Our Programs

Master Plumbers Association – Canberra ACT (MPA) has implemented and sustained a range of programs aimed at ensuring consumer protection, environmental sustainability, and support for vulnerable groups in our community.
